The Club at PrairieStar, LLC consists of a fitness facility and swimming pool (the "Club") located in the PrairieStar Development in Berthoud, Colorado. The Club is designed to provide an inviting, fun and safe place for neighbors to enjoy the pool amenities as members of the Club. The undersigned ("Member"), desires to become a member of the Club, and agrees to the following terms and conditions:

1. MEMBERSHIP Your Membership is a contractual privilege to the Club premises, facilities, and equipment during the Club's hours of operation. The membership dues and other charges payable by the members, the suspension and termination of members, and all other matters affecting or relating to your membership shall be under complete control of the Club. Your Membership may include the following: **Seasonal Membership** - Individual Membership or Couple Membership. Couple is defined as any 2 adults living in the same household | \$200/\$300(individual/couple)

Household Dependents - Children (18 years and under) | \$55 per child – for the first 3 children (\$165 maximum.) No additional fees for more than 3 children. \$55(per child)

Anyone using the Club is required to execute a Release and Waiver of Liability and Indemnity Agreement prior to their initial use of the Club. Your Membership is also subject to all persons using the Club under your Household Membership. Only registered Members and persons registered as Household Dependents may use the Club. No guests are allowed.

- 2. PAYMENT OF MEMBERSHIP FEES All payments to the Club are final and can be made by the following: a. Seasonal Payment. Payment for Individual Membership or Couple Membership, any Household Dependents.
- **3. TERM/CLUB RIGHT TO EARLY TERMINATION** All memberships of the Club are seasonal (when paid in full), and payments are due in advance. No refunds will apply. The Club season for 2024 is scheduled for end of May through early September. The Club reserves the right to terminate this Agreement early. In the event of early termination, prior to September, the Club will provide a pro-rated refund of fees paid to Member.
- **4. MEMBERSHIP ACCESS** Member will be issued one access key fob per membership, which will entitle Member and registered Household Dependents to enter the premises and enjoy the use and benefit of the facilities of the Club consisting of the clubhouse and swimming pool (collectively, the "Facility"). Member agrees NOT to allow any other person(s) access to the Facility using Member's access fob. Member agrees to safeguard the access fob. Should Member violate any conditions of Membership Access, the membership may be revoked with no refund, and criminal prosecution may be applicable. If lost or stolen a replacement fob fee is \$40. All access key fobs must be returned to Club Management at the end of the Club season.
- **5. MEMBERSHIP CANCELLATION BY CLUB** Under no circumstances will refunds of dues be made retroactively due to failure to use the Club facilities. Any member who, in the sole determination of the Club, is loud, offensive, uses profanity, is bothersome to other members/employees or behaves otherwise in an inappropriate or unbecoming manner or who is cited for infraction of the Club Rules and Regulations may be suspended or terminated from the Club.

The Club reserves the right to terminate any membership for violation of the Club's Rules and Regulations of the Club by notice to you. Any removal or defacement of Club property or another member's property will result in immediate termination. If the Club cancels your membership by notice to you, you must immediately surrender your access fob. You will remain liable for all unpaid dues and other charges for

periods prior to the termination date, including any damages caused. No refunds shall be made for membership dues except as specifically provided for in the agreement.

6. FACILITY AND HOURS OF OPERATION The Club includes an unmanned swimming pool that, with the exception of any closures for maintenance or any mandatory shutdowns by property management or any governmental authority, has operating hours, 7 days a week during the season of:

Pool Hours: 7:00 am to 9:00pm, subject to weather closures

Fitness Center Hours*: 5:00 am to 11:00 pm

- *The Yoga Room will be unavailable on Tuesdays and Thursdays from 5pm 8pm
- 7. RELEASE, WAIVER OF LIABILITY AND INDEMNITY Member recognizes that there are hazards and risks connected with physical fitness training and swimming pools. These risks include, but are not limited to, drowning, broken bones, abnormal blood pressure, fainting, heart disorders and heart attack, dehydration, heat exhaustion, sprains, muscle strain, blisters, stress fracture, shin splints, tendonitis, cartilage tears, bursitis, back pain and bruising of joints. Exercise beyond one's physical limits and/or accidents involving exercise equipment may result in serious injury or even death. Use of the swimming pool can result in severe injury and even death due to among other things drowning. Member does hereby completely assume the inherent risks associated with the use of Facility, premises or equipment provided by the Club. Member acknowledges that swimming, fitness and conditioning activities, by their very nature, carry with them certain inherent risks that cannot be eliminated regardless of the care an individual may take to avoid them. Member agrees to defend, indemnify and hold harmless the Club against any loss, damage or expense incurred by reason of any claim or liability based upon personal injury (including death) or property damage arising out of the negligent or intentional action of Member. Member further agrees to release waive, discharge, and covenant not to sue, and defend, indemnify and hold harmless the Club, its owners, officers, members, managers, employees, subcontractors, affiliates, volunteers, and agents ("Indemnified Parties") from claims, liabilities, suits, damages, costs and expenses (including without limitation reasonable attorney's fees and costs) resulting from damage to, loss of, or theft of personal property, claims resulting from use of Club, premises or equipment provided by any of the Indemnified Parties and resulting from personal injury (including death) from accidents or illness arising directly or indirectly from activities provided, directed, suggested, or planned by any of the Indemnified Parties. Member acknowledges that surveillance cameras are in use for the protection of the Facility, its equipment and its members. Member hereby consents to being photographed and/or recorded for such purposes.
- **8. PHYSICAL ACTIVITY READINESS** Member, on behalf of yourself, represents that:
- **a.** you are voluntarily engaging in physical exercise, are in good physical condition and have no disabilities, diseases, illnesses or other conditions that could prevent you from exercising and using the club without injuring yourself/themselves or impairing your/their health;
- **b.** you have consulted a licensed physician concerning an exercise program that will not expose you to risk of injury or impairment to your health; and
- **c.** your physician has approved your contemplated activities at the Club. You are relying solely on the advice of your/their licensed physicians regarding the ability to use the Club facilities.

- 9. RULES AND REGULATIONS Member acknowledges receipt of the Club Rules and Regulations (the "Rules"). The Rules shall be considered a part of this Membership Agreement. Member acknowledges that the Club operates under rules and regulations established for the safety and protection of its members and agrees to be bound by such rules and regulations, as well by the rules and regulations subsequently approved and posted or otherwise published by the Club. Such rules and regulations in effect from time to time are incorporated into this Agreement by reference. Facilities, equipment, hours, service, regulations and policies are subject to change from time to time, without prior notice, in the sole discretion of the Club. Member agrees to accept such reasonable change(s) as a condition of membership.
- 10. COUNTERPARTS This Agreement may be executed simultaneously in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same agreement.
- 11. HEADINGS The headings in this Agreement are inserted for convenience only and shall not constitute a part of this Agreement.
- 12. BINDING EFFECT This Agreement shall be binding upon, inure to the benefit of, and be enforceable by the parties hereto and their respective successors and assigns.
- 13. ENTIRE AGREEMENT This Agreement, including the schedules, lists and other documents referred to in this Agreement which form a part of this Agreement, embody the entire agreement and understanding of the parties with respect to the subject matter contained in this Agreement. There are no restrictions, promises, warranties, covenants or undertakings, other than those set forth or referred to in this Agreement. This Agreement supersedes all prior agreements and understandings between the parties with respect to each subject matter.
- 14. GOVERNING LAW This Agreement, and all documents mentioned herein by reference, shall be governed by the laws of the State of Colorado.
- **15. FURTHER ASSURANCES** The parties agree to execute such further documents as may be necessary, proper or convenient, for the purpose of fully effectuating the terms and conditions of this Agreement.
- 16. SUSPENSION AND TERMINATION I understand that the Club may suspend or terminate my membership at any time, in its sole and absolute discretion, for non-payment of Membership Fees or for violation of any of the Club's policies and procedures, and that in so doing, the Club assumes no further liability to adhere to the terms of this Agreement.
- 17. ACCEPTANCE OF TERMS As a Member, I understand that I am entitled to use the Facility within the scope of the membership that I have selected, and that I am obligated to pay my dues and fees regardless of whether or not I use the Facility. I agree to promptly update the Club of any change in my contact information (including address, telephone number or email address) or change in credit information. I certify that I have read the foregoing Membership Agreement, and that by signing below, I acknowledge that I understand and agree to be bound by all of the terms and conditions hereof and specifically acknowledge that I have read and understand the RELEASE AND WAIVER OF LIABILITY SET FORTH IN SECTION 7. I further acknowledge that a fully executed copy of this Membership Agreement has been provided to me.

MEMBER RIGHT OF RESCISSION – MEMBER HAS THE RIGHT TO RESCIND AND TERMINATE THIS AGREEMENT WITHIN 3 DAYS OF EXECUTION OF THIS AGREEMENT BY MEMBER AND RECEIVE A FULL REFUND. Member further acknowledges the Covid-19 related risk associated with using the Club's facilities and as more specifically described in the attached Covid-19 Assumption of Risk Rider as a part of this waiver and indemnity.

NO LIFEGUARD IS PROVIDED AT THE POOL AND ALL PERSONS USING THE POOL DO SO AT THEIR OWN RISK.

The following rules are to ensure that all Members may enjoy The Club at PrairieStar (the "Club") consisting of a swimming pool (the "Facility")

in a safe and clean environment.

1) Pool hours - 7:00 AM to 9:00 PM

End of May through early September (weather permitting) NO LIFEGUARD ON DUTY

Fitness Center hours* - 5:00 AM to 11:00 PM

*The Yoga Room will be unavailable on Tuesdays and Thursdays from 5pm - 8pm

Any use after these hours will be treated as a trespass and the police will be called.

If you see anyone in the pool area after hours please call the Police at 970-532-2611 or Management at 720-276-1950.

- 2) The Club is for the exclusive use of Members. All Members must read and acknowledge familiarity with these rules. The Member is responsible for the conduct of his or her household members. No guests will be allowed for the 2024 season.
- 3) Members MUST accompany and are responsible for all actions of their children under 14 at the Club. An adult MUST supervise children in the pool from inside the pool enclosure at all times.
- 4) The Club requires that Members wear appropriate clothing and footwear while in the Facility. Appropriate clothing includes gym shorts, Tshirts,
- jogging suits, aerobic wear, sweat outfits and appropriate swim attire for the swimming pool. Street clothing and jeans are not considered appropriate clothing. Street shoes and black-soled shoes are prohibited within the Facility. Members must bring towels for the pool.
- 5) All persons using the pool must be hygienically clean and free of sweat, or must shower prior to entering the pool.
- 6) Persons having infectious diseases, open sores, cuts or wounds or recent vaccinations CANNOT use the pool, until such time that such condition is cured.
- 7) NO running, pushing, rough play, dunking, excessive splashing, foul language, screaming, loud noises, jumping, horseplay or diving is permitted.
- 8) NO alcohol permitted in the pool or any other part of the Club.
- 9) NO smoking or illegal substances are permitted in the pool or any other part of the Club.
- 10) Do not allow anyone to use your access key fob to enter the pool without you. Violations may result in the immediate suspension of your right to use the pool for the remainder of the season.
- 11) Radios, tape or cd players, boomboxes, televisions and other electronic devices may be used in the pool area with headsets ONLY.
- 12) The Facility is off limits to all pets, including the pool enclosure.
- 13) NO glass containers are allowed in the Facility.
- 14) NO debris may be thrown into the pool.
- 15) NO foreign objects (floating rafts, balls, etc.) are allowed in the pool on weekends or when pool is crowded, EXCEPT for children's safety floats.
- 16) NO objects are to be hung on the fences.
- 17) NO personal objects such as chairs or mats are to be left in the pool area overnight. Take what you bring, no storing.
- 18) NO consumption of food or drink is allowed in the pool.
- 19) NO one is allowed in the pool when there is visible lightening and for 30 minutes thereafter.
- 20) Members and guests must remove all personal items when finished, inside and outside of the Club and dispose of trash in the containers provided.

- 21) If needed, swim diapers are required in the pool.
- 22) NO political, religious, commercial or outside organization is permitted use of the Club, even if a Member is a member of the organization.
- 23) NO wheeled objects, such as bicycles, skates or skateboards are permitted in the pool area.
- 24) Obnoxious and/or drunk persons may be removed from the pool area and their right to use the pool may be suspended without further warning.
- 25) Please try to keep noise at a reasonable level. Be considerate of the neighbors that border the pool.
- 26) NO offensive or abusive language will be tolerated anywhere at the Club. Anyone using such language will be asked to leave.
- 27) NO climbing over a gate or fence to enter the pool. If you have lost your access key fob, call Management for a new one. Do not open the
- gate/door to anyone who does not have a fob.
- 28) The pool will be available to Members who want to subscribe from 7:00 am to 9:00 pm., 7 days a week, end of May through early September, weather permitting.
- 29) All parties will sign appropriate receipt of operating procedures and Covid disclosures.
- 30) People will not be asked to warrant or show that they have been vaccinated.
- 31) If you have not been vaccinated, wear a mask.
- 32) Cleaning of the surfaces of the pool and of the bathroom facilities will occur daily.
- 33) Maintain social distancing (6 feet) from members of other families both in and out of the water.
- 34) Our pool technician will be sampling and monitoring water quality and chlorine content 2 3 times a week.
- 35) The barbecue grills will be available for use. Members must bring all their own BBQ needs. None will be provided.
- 36) Members shall bring and remove all personal belongings, including pool toys, when leaving.
- 37) Use the fitness center at your own risk. No trainer is on duty.
- 38) Member should not occupy any equipment for an extended period of time. Member should allow others waiting to use such equipment to work into their rotation.

- 40) Wipe down equipment in fitness center after each use. Clean up after yourself and your guests. Place equipment back to its proper location. Large exercise equipment (e.g. treadmills, ellipticals, bikes, etc.) shall not be moved.
- 41) Members agree to maintain social distancing per state and local guidelines, and acknowledge that such guidelines are subject to change.
- 42) By signing this agreement, Members acknowledge that they have been advised not to join the Club if they are uncomfortable with any of the
- rules, or operations of the Club.
